


3.4 Seminar/Webinar/Workshop:

Many had on Experience including IWWA Mumbai Centre Chairperson Ms. Manishaa Palande.




3.5 Activities of Youth Forum:



Report on Audit of Financial Statements

Opinion

We are independent of the IWWA, Mumabi Centre in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined the matter described below to be the key audit matters to be communicated in our report. It is to be noted that HDFC fixed deposit interest received for the year includes Rs. 1,27,500/- being interest pertaining to previous year. This is because, in the absence of non-receipt of interest certificate from the bank during previous years, the branch had accounted for same on estimate basis @ 5 percent per annum. However same is received by branch during year under report and hence difference between actual interest accrued as per certificate and estimated previous year is recognized as interest for the year.

Management's Responsibility for the Financial Statements

The Management is responsible the preparation of these financial statements, that give a true and fair view of the financial position and financial performance and cash flows of IWWA, Mumbai Centre in accordance with the accounting principles generally accepted in India.

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the IWWA, Mumbai Centre and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to
